### Offences Act 1963

#### AN ACT

To adopt the canon of the Church of England in Australia entitled the "Offences Canon 1962" and for other purposes.

WHEREAS a canon was passed by the General Synod of the Church of England in Australia entitled the "Offences Canon 1962" AND WHEREAS it is expedient that the said canon should be adopted by the Church in the Diocese of Melbourne.

BE IT ENACTED by the Archbishop the Clergy and the Laity of the Church of England in Australia within the Diocese of Melbourne in Victoria duly met in Synod according to Law as follows:

#### *Title*

1. This Act may be cited as the "Offences Act 1963".

#### Order and Good Government

2. In accordance with the provisions of the Constitution of the Church of England in Australia this Synod is of the opinion that the provisions of the Offences Canon 1962 passed by the General Synod of the Church of England in Australia a copy of which is contained in the Schedule here to affect or are deemed to affect the order and good government of the Church in the Diocese of Melbourne.

#### **SCHEDULE**

### No. 4, 1962 A CANON TO SPECIFY OFFENCES UNDER SECTIONS 54, 55 AND 56 OF THE CONSTITUTION

The General Synod prescribes as follows:-

### Offences Clerical

- 1. A Diocesan Tribunal and a Provincial Tribunal in its original jurisdiction in addition to their respective powers under Section 54 (2) and Section 55 (3) of the Constitution may hear and determine charges made in respect of the of the following offences alleged to have been committed by a person who, at the time the charge is preferred, is licensed by the bishop of the diocese or is in holy orders resident in the diocese:
  - 1. Unchastity.

- 2. Drunkenness.
- 3. Habitual and wilful neglect of ministerial duty after written admonition in respect thereof by the Bishop of the diocese.
- 4. Bankruptcy
- 5. Wilful failure to pay just debts.

- 6. Conduct disgraceful in a clergyman and productive or likely to be productive of scandal or evil report.
- 7. Any offence punishable by law being a malum in se.
- 8. Any other offence prescribed by an Ordinance of the Ssynod of the Diocese.
- 2. (1) The Special Tribunal in addition to its powers under section 56(2) of the Constitution may hear and determine charges against any member of the House of Bishops made in respect of the following offences:
  - 1. Unchastity.
  - 2. Drunkenness.
  - 3. Bankruptcy
  - 4. Wilful failure to pay just debts.
  - 5. Conduct disgraceful in a clergyman and productive or likely to be productive of scandal or evil report.
  - 6. Any offence punishable by law being a malum in se.
  - 7. Wilful violation of the Constitution or of the canons made thereunder or of the Ordinances of Provincial Synod or of his Diocesan Synod.

- 8. Any conduct involving wilful and habitual disregard of his consecration vows.
- (2) Any charge shall be in writing and shall be lodged in the Registry of the Primate together with a short statement of the evidence in support thereof.
- 3. This canon may be cited as the "Offences Canon 1962".
